- Acted for departing employee in an interim and interlocutory injunction application. The Court ultimately concluded that the plaintiff had not established a strong prima facie case that the restrictive covenants were reasonable (2012 NSSC 234 (CanLII)).
- Acted for employer who hired several departing employees from a competitor. We addressed all aspects of the restrictive covenants, including a threatened injunction application.
- Frequently reviews restrictive covenants, both for departing employees, current employers and prospective employers to consider enforceability of applicable contractual obligations.
